## President's Report

* Significant Growth
*Goal of expanding electronic signature in 2022/23 and implementing a plan for member accounts, off-site voting, Zoom meetings, etc.
*Frustratingly, the Audit is not back. We may have to pursue new firm. We are looking into this
*Great effort is being made to be open and transparent, including great effort to find $\$ 100,000$ in missing equipment, attempting to stop cash transactions because of missing memberships, no more lying about fire band, etc.
*Apologize and explain membership struggle on Dumpster Day and previous years. There seems to have been some treasurer issues with miscalculating membership so that members would have to pay earlier than it was due.
*Fun Fest--especially the Raffle, Silent Auction, and beer/soda/water table.
*Explanation that we are a "Ranch Owner Committee Group," but we are not a traditional HOA.
We can't enforce, demand compliance, or anything else. Apologize for those who have previously been promised what we can't do or should not have.
*Explain how we help community--communication, crisis support of Ranch Owners, support charities that serve the Ranches in a non-monetary format including the fire department, San Luis Food Bank (canned food from funfest), the Fort (paid for their space for funfest), American Legion, VFW and VA (free booths at funfest), Trinidad State College, Adams State College, Community Center, Department of Wildlife, COVID shot option, free tablet option, Fire Dpt, and more.
*Explanation of effort to promote Ranch Owned businesses including a free ad in the Pinion and our desire to put them on our website. We are not endorsing these businesses. We recommend always checking references and work first.
*Explanation of why we are here to nominate and not elect. Explain positions and inform current treasurer did not attend meeting about her position or answer email.
