Membership Issues

Issue: On multiple instances over the last year and in previous years members have claimed they joined the HOA, but their membership was never placed onto the HOA books.

It was assumed the members with unrecorded memberships had paid in cash. Though still possible in some instances a new possible explanation has arisen recently.

Early on the "Dumpster Day" Pam Thompson provided fellow board member Bruce Nagel, with a list of current members so that it could be verified that those dumping were in the HOA.

Bruce examined the membership list and discovered that his membership was missing though he had paid for his membership with a verifiable check eight to nine months earlier.

Knowing the membership roles were not accurate and out of a great concern for integrity it was determined we could not use the HOA membership roles as a way to verify who could use the dumpsters. As a result, many used the dumpsters who probably were not eligible to do so. Though the exact amount is not verifiable the dumpsters ended up costing about \$800 to \$1,000 extra it appears.

HOA President Doug Anderson, brought up that we now know for certain memberships had not

been kept on the rolls for known members.

Pam Thompson responded with denial of that occurring and asked for proof. Doug Anderson pointed out Bruce Nagel and asked him to explain his own plight.

Doug Anderson asked Pam Thompson if she could explain the situation.

Pam responded with the following explanations:

That it was just a matter that she accidently printed the list from the wrong date.

Pam explained that current members whose membership was due to come due at a future date were presented with the false claim that they were no longer members and their yearly membership needed to be paid.

When pushed on the integrity of the procedure Pam seemed to defend her action before pointing out she had done the same thing on purpose in previous years. Pam further made it clear this year's incident was not accidentally, but was on purpose to gain membership dues early.

Shortly, the explanation changed to a statement that this is how she does it every year to gain members.

It was discussed that when someone pays dues it should be reflected within 48 hours

It was decided that everyone is covered and grandfathered in until August Annual meeting.

It was decided the board needs to come up with a solid plan by the August meeting for how things will be recorded and what to do about this issue with the treasurer, but we will table this until then.
